Prior authorization is not required for any smoking cessation therapies.

Lead Screening

The Connecticut Department of Public Health recommends universal lead screening for children in Connecticut. For children in Medicaid, the EPSDT program mandates:

- Lead risk assessment beginning at **six months** of age
- Blood lead tests for all children in Medicaid at **12 months** and at **24 months** of age
- Children up to **72 months** of age who have not previously been screened should also be tested.

******* CONNECT Card and CHNCT Member ID Card *******

The DSS **CONNECT Card** and the **CONNECT Child Card** is issued to all Medicaid eligible recipients once they qualify for the State of CT Medicaid Program. These cards are not to be mistaken for a **CHNCT Member Identification Card**. If a Medicaid recipient presents this card for services at your office, you must inform them this is not their MCO Identification card. They must present the appropriate card. Eligibility must be checked with CHNCT (for CHNCT members) prior to rendering the service or submitting the bill for payment. Having a CONNECT Card does not automatically qualify anyone for services with CHNCT or any other Medicaid Managed Care Organization.

CONFIDENTIALITY OF MEDICAL RECORDS

The relationship and communication between provider and patient is privileged and confidential. The physicians code of ethics as well as Connecticut and Federal laws protect against the disclosure of the contents of medical records to persons or agencies not properly authorized to receive such information. **Family planning, behavioral health and substance abuse information must be treated with particular sensitivity to confidentiality, and may be released only by the patient, even if the patient is a minor.** (Consult your malpractice carrier for specific circumstances.)

To further assure the members' privacy, only medical record personnel and health professionals inside CHNCT who are directly involved in the delivery or evaluation of that patient's care have access to an individual patient's records. All requests for medical records information must be handled according to this policy.
